## Minutes of 18th meeting held on 28 Jan, 2022

The meeting was held at Townscape, Nasir Bagh Road, Peshawar, attended by members, list annex-1.

The members showed grave concerns about the very prolonged delay in payment of Commutation and other pension liabilities of the retired academic and administrative officers. It was mentioned that the administration of the University of Agriculture Peshawar (UAP) does not include payment of Commutation and Encashment to the retired officers, in the priority list of the University. The payment of such liabilities must have been made to the retired employees, mandatory within a month of retirement, enabling them to work on construction of their own houses and other major family needs. UAP is bound to pay the pension liabilities within two weeks of retirement as per directives of the Supreme Court of Pakistan endorsed by the Government of Pakistan Finance Division vide office memorandum No. F-11(1)-Reg.6/2013 dated 3-5-2013.

Eighteen meetings of EPCA were held demanding a solution to the issues at the level of UAP, Civil Secretariat, Chief Minister, Governor and HEC and minutes were shared with all concerned. An Appeal was submitted to the Governor Khyber Pakhtunkhwa on 19-5-2022 for providing relief to the affectees. During the meantime, UAP released 40% of commutation to the members retiring up to Prof Shafi, escaping Prof Rafi.

To achieve the EPCA goals of getting relief to the retired officers, the following committees were constituted:
