General Guidelines

Abstract

- Abstract may composed of 300-350 words.
- The single space may be used between lines.
- The theme font “Times New Roman” required to be adopted throughout text with font size 12 except suggested for specific area i.e., title.
- Title may be written in “Sentence case” with font size 14.
- Complete names of authors are required to be used in “Sentence case” with font size 12 and place in “centered”.
- Name of authors may be numbered for showing affiliations using superscript.
- Affiliations may have complete institution/university/department name, location, region/province, country name and email of each author in separate lines. The font size 10 may be used and aligned to left.
- The text of abstract may be justified.
- Key words should not be more than five words. Each key word may be separated by comma texted in lower case except first key word.

Full Length Paper

- The overall limit of Similarity Index Report of paper should not be >19% whilst the limit from any single source must be within 5%.
- The paper must not exceed the limit of 5,000 words including references.
- The manuscript must be composed of Abstract, Introduction, Materials and Methods, Results and Discussion, and References.
- The theme font “Times New Roman” with font size 12 may be used throughout manuscript with 1.5 line spacing.
- The single line space required be used in References whilst line space 1.5 may be used between References.
- Tables also required to be arranged at single space.
- References at the end of manuscript must be arranged alphabetically.
- Citations may be written as: Qureshi (2021) or (Qureshi, 2021), Marghazani and Qureshi (2020) or (Marghazani and Qureshi, 2020), Mansoor et al. (2022) or (Mansoor et al. 2022).
